### Introduction

  - **Wallet Address:** The ETC wallet address you provided when you purchased this device
- 3.2. **Personal Use Only:** The software is for your personal use. Linked email/wallet addresses are non-exchangeable and should not be used for others.
- 3.3. **Single Device Licence:** Each NFT licence is valid for use on a single device only. Unauthorised use on multiple devices is prohibited.

- 3.4. **False Claims Policy:** Misuse or false claims regarding software use may result in non-payment and potential license revocation.
- 3.5. **No Premining Without License:** Premining without a valid license is strictly forbidden.
- 3.6. **Right to Ban:** ETCMC reserves the right to ban any user for fraudulent activities or violation of these terms.
- 3.7. **NFT License Requirement:** Users must hold the NFT license in their wallet address until the reward has been received. If the NFT license has been listed on the marketplace, you no longer own that NFT license and are not entitled to be rewarded for running that node.
- 3.8. **Tampering, Decompiling, and Reverse Engineering:** Tampering with, decompiling, or reverse engineering the software is strictly forbidden and will result in a permanent ban and revocation of all NFT licenses.
- 3.9. **Account Security:** Users are responsible for maintaining the confidentiality of their account information and for all activities that occur under their account. ETCMC is not liable for any loss or damage arising from your failure to protect your account information.
- 3.10. **Compliance with Laws:** Users must comply with all applicable laws and regulations in connection with their use of the software. Any illegal use of the software will result in immediate termination of the license.
